Glenn and Kristil first shared information that needed to be filled out for the MN Department of Education and NEO (SIP document).

Glenn explained the SMART GOALS established for Math and Reading MN state accountability test and Graduation Dropout percentages based on data from MN state accountability tests.

- Math: State Accountability Test will Increase from 13.2% in 2013/2014 to 18.2% in 2014/2015
- Reading: State Accountability Test will Increase from 41.4% in 2013/2014 to 46% in 2014/2015
- Graduation Dropout Rates will Decrease from 16% in 2013/2014 to 10% in 2015/2016

Kristil and Glenn also developed a data chart that reviews the 'Exploration Stage' that depicts a comprehensive needs assessment for students at NCA based on our current collection of data- NWEAs, MCAs, Graduation Requirements, and Attendance.
